# Summary

Gansu Golden Solar Co., Ltd., ("Golden Solar") are pleased to offer an Enhanced Limited Warranty for its Heterojunction solar photovoltaic Modules ("HJT Modules"), which contains the following elements.

Upon entering into a procurement transaction between the Buyer and Golden Solar for the aforesaid HJT Modules, such HJT Modules will be covered by the terms of the enhanced limited warranty certificate ("EL Warranty") that shall be issued as part of and become an integral part of such transaction. This document provides a summary of the relevant details as contained within the EL Warranty.

# 1. Warranted SPV MODULES:

- JGDN108B-XXX-YY
- JGDN144-XXX-YY
- JGDN120-XXX-YY
- JGDN132-XXX-YY

Where;

XXX = nominal power output, & YY = cell size and number of busbars

# 2. EL Warranty Start Date

The EL Warranty contains a pragmatic approach to the warranty start date and provides a choice of three, conditions based, potential start dates to reflect real life operations and requirements.

# 3. EL Warranty Duration

The EL Warranty contains both an EL Product Warranty, and an EL Power Warranty.

The duration of the EL Product Warranty is fifteen (15) years after the warranty start date, and the duration of the EL Power Warranty is thirty (30) years after the same warranty start date.

There is also a conditions based element wherein the aforesaid periods may be greater than stated, without cost to the Buyer.

# 4. EL Power Warranty

Offering both HJT technology based and PV sector based, industry leading power retention over the EL Power Warranty duration, the annualized retained power is 99% after year 1, reducing by 0.3% per year thereafter.

# 5. EL Warranty Remedies

The EL Warranty contains five (5), conditions based, generic remedies that include repair, replacement, provision of additional HJT Modules, refunds and financial compensation, depending upon the detail of the failure of HJT Module.

In the event of the remedy being a replacement, or provision of additional HJT Modules, such replacement will be made under DAP (Incoterms 2020) conditions, irrespective of the original purchase conditions.

Further in addition to the generic five remedies as above, there are numerous additional supplemental remedies to support the reclamation of direct costs that may be incurred by the Buyer resultant from, the failure of the HJT Module, the choice of generic remedy, the fact that a warranty claim may be made on HJT Modules that are no longer in production, or the time of execution or completion of the generic remedy.

# 6. Limitation of Liability

The EL Warranty acknowledges the remedies should allow for full reinstatement of the operation of the defective HJT Module, and should not limit the provision of any supplemental remedies, and therefore the EL Warranty contains conditions based limitation of liability elements that exceed 100% of the price of the HJT Modules.

# 7. Legal statements

This document is provided in good faith as a summary of content within the EL Warranty. Nothing contained within this summary document should be construed or interpreted to be a binding commitment for provision of obligation or liability



pursuant to the content herein. In the event that such content is in conflict with the content of the EL Warranty, the contents of the EL Warranty shall prevail.

This document is issued on 10/03/2024 and may, at Gansu Solar's sole discretion, be replaced from time to time, or withdrawn without notice, without incurring liability or obligation, resultant from such action.
